19 (c) Defendant's production of Class List to Plaintiff and the Class Administrator by:

20 11.21.25 (i.e., fourteen (14) days following the Court's Order
21 approving Class Notice). The Class List shall include the Class Members' names, last known
22 addresses, as well as email addresses and phone numbers where available; the Class Members'
23 deposit amounts; and the Class Members' date of termination of tenancy.

(d) Deadline for Class Administrator to commence dissemination of Class Notice to Class Members: 12.22.25 (i.e., within thirty (30) days after Defendant's production of Class List).

(e) Deadline for Class Members to submit for exclusion postmarked by: 2.20.26 (i.e., no later than sixty (60) days after the date in subsection (d) above).

(f) Deadline for Class Member objections to be filed with the Court and delivered to the Parties' counsel: 2.20.26 (i.e., no later than sixty (60) days after the date in subsection (d) above).

(g) Plaintiff's Motion for Entry of Final Judgment for Class Damages, Attorneys' Fees and Costs, and Class Representative Service Award shall be filed by: 3.20.26 (i.e., at least fourteen (14) days before the hearing date in subsection (j) below).

(h) Defendant's Response to Plaintiff's Motion for Entry of Final Judgment for Class Damages, Attorneys' Fees and Costs, and Class Representative Service Award shall be filed by: 3.27.26 (i.e., at least seven (7) days before the hearing date in subsection (j) below).
